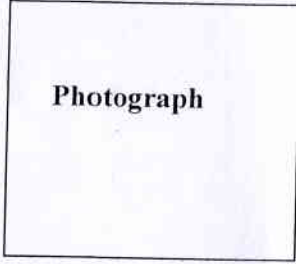
5. Initial period of engagement shall be for Six months which can be extended further, if required.
