TERMS AND CONDITIONS

Reference to tender call notice No 14526 dt. 27.07.2018

- 1) The requirement of summer worthy uniform materials with its specifications and quantity are specified in annexure-A. The notified quantity may be changed depending on actual requirement at the time of issuing purchase order. The bidders are requested to attach sample cut pieces of uniform materials for verification and selection of its quality. Priority will be given for good quality and brand of the uniform cloth.
- 2) Tender offer is to be given in the prescribed format as enclosed at Annexure-'A'
- 3) The sealed tender(s) should be accompanied with two bank drafts i.e one of Rs.200.00 + GST 5% towards cost of tender paper (Non-refundable) and another of Rs.10,000/- (Rupees ten thousand) only towards Earnest Money Deposit (EMD) drawn in favour of Odisha Forest Development Corporate Ltd both from any nationalized bank and payable at Bhubaneswar, failing which the tender shall not be taken into consideration. The EMD of successful tenderer will be kept as Security Deposit till completion of supply of required uniform clothing and the EMD of un-successful tenderer will be returned soon after finalization of the tender.
- 4) The tenderer(s) should submit copy of GST registration certificate and income tax PAN card for reference. In case of non-submission, the tender shall not be taken into consideration and rejected.
- 5) The bidder has to quote their rates for all items. In case of omission of any item in their tender paper, his offer will not be taken into consideration.
- 6) The approved tenderer will deliver the required quantity of uniform materials at our Corporate Office located at A/84, Kharvelnagar, Bhubaneswar within 30 days from the date of issue of purchase order without any extra cost, failing which the security deposit will be liable for forfeiture along with cancellation of order. In that eventuality, the required materials shall be purchased by the Corporation from other firm or from market at the risk of the approved supplier and any excess amount spent for such purchases beyond the norms if any shall be recovered/compensated from the approved supplier.
- 7) The Corporation reserves the right to accept or reject any part or the whole tender without assigning any reason thereof.
