1.Sealed tenders are invited in the prescribed format (Annexure-I & II) from the intending purchasers/ firms for purchase of Commercial Bamboo of 2016-17 crop to be extracted by OFDC. The Division wise and depot wise estimated availability of commercial bamboo is furnished below:

- 2. Specification of Long Bamboo: Average length of Salia long bamboo (Dendrocalamus strictus) is around 06 meter with butt end girth not below 10 Cm and the average length of Daba long bamboo (Bambusa Arundinasia) is 06 meter and above with butt end girth not below 25 Cm.
- 3. The tenderer is required to be registered with Sales Tax Authority of Odisha having VAT/CST TIN number.
- 4. Participation in the tender will be deemed for all purposes as unconditional acceptance of all the terms and conditions by the tenderer.
- 5. The tenderer may contact the concerned Divisional Manager of OFDC Ltd. on any working day to ascertain about the quality and quantity of the Commercial Bamboo and location of depots in the Division. The intending tenderer may inspect the depots and stocks available therein and quote ex-depot purchase price per piece of Commercial Bamboo in whole rupee exclusive of all taxes, levies, fees, duties etc.
- 6. The intending tenderer is required to pay Rs.50,000/-(Rupees fifty thousand) only towards Earnest Money deposit(EMD) in shape of Bank Draft drawn on any nationalized Bank in favour of OFDC Ltd. and payable at Bhubaneswar along with the tender offer. Offer without requisite amount of EMD will be invalid and

rejected. In case the tender is accepted, the Earnest Money so deposited will be adjusted towards the part Security Deposit. The Earnest Money will be refunded to the unsuccessful tenderer (s) as such.

- 7. The tenderer will not be eligible to rescind or withdraw his offer between the date of tender and the date of final approval by the Corporation provided that the date of final acceptance does not exceed 30 days after the date of opening of the tender. In the event of violation of this provision, the EMD will be forfeited.
- 8. The tenderer, whose offer is finally accepted shall pay Security Deposit (SD) @ 10% of sale value of the notified stock of the depot(s) in shape of Bank Draft obtained from any nationalized Bank within 15 days or else the sale will be deemed to be rescinded and the EMD/part Security Deposit (SD) paid by the tenderer will be forfeited. The Managing Director, OFDC Ltd. will be at liberty to forfeit the whole or any part of the Security Deposit for non-performance of the contract or for any default of the tenderer.
- 9. After payment of Security Deposit, the purchaser/ tenderer shall be required to execute an agreement with the Corporation within 7 days of such payment. A sample copy of the agreement may be seen in the Office of the Managing Director, OFDC Ltd., A/84, Kharvelanagar, Bhubaneswar on any working day during Office hours. All the terms and conditions of this tender shall be treated as part of the agreement whether specifically incorporated or not.
- 10. The successful tenderer has to make full payment of sale value against the total available stock at depot(s)/ Division for which he has bidded, in one installment within a month on receipt of intimation of the Divisional Manager. In case of default the Security Deposit is liable to be forfeited and the sale will be automatically treated as cancelled and the lot(s) will be disposed off otherwise at the discretion of Corporation.
- 11. The supply of bamboos shall be made to the tenderer against payments of full sale price of bamboo in advance in accordance with clause -10 above. The successful tenderer shall take delivery of the said Commercial Bamboo within 7(Seven) days of receipt of allotment order by the concerned Divisional Manager, or else it would be deemed to have been delivered to the purchaser from 8th day of allotment. The Corporation shall not be liable for any loss or damage caused to such bamboos taken delivery by the purchaser.
- 12. In addition to the payment of sale value at Divisional level, the purchaser shall pay to the Divisional Manager concerned, the due taxes and duties etc. as applicable. For delayed payment of sale value and other dues if any interest @ 15% per annum is to be paid by the purchaser. Taxes and other dues as shall be deemed and become due on the date of raising of bills and should be paid by the purchaser immediately in the Office of the concerned Divisional Manager.
- 13. The successful tenderer shall remove the allotted bamboo within a period of 30 days from the depot or else land rent at the rate of Rs.0.05 (five paise) per piece of Commercial Bamboo per month or part of a month will be payable by the purchaser to the Corporation from the date of expiry of the above mentioned time limit up to 60 days from the date of delivery. There after the unlifted delivered Commercial Bamboos shall become the property of the Corporation and the Managing Director may dispose off such bamboos in any manner he likes and the purchaser shall have no claim over any sale proceeds of such bamboos. Provided further that, if the Managing Director thinks that there exits sufficient reasonable ground for non removal of delivered bamboo within the prescribed period of 60days of delivery, he may further extend the period of removal of such bamboo up to a further period of 30 days with realization of double the land rent.
- 14. The tenderer shall be bound to abide by all the rules and regulations of Forest Department in connection with the purchase and transit of the forest produce.
- 15. Any letter communicated or notice sent by registered/speed post to tenderer or his agent, will be deemed to have been served on him/ them even if it returns undelivered.

- 16. The Managing Director, OFDC Ltd. reserves the right to reject any or all the tenders without assigning any reason thereof.
- 17. Only in exceptional circumstances and in case of genuine difficulties, the Managing Director may at his discretion relax the limitations stipulated in these terms and conditions.
- 18. Only the courts at Bhubaneswar will have the exclusive jurisdiction over all litigations that may arise out of these transactions and no litigation shall be instituted in any court at any other place other than Bhubaneswar.
