CORRIGENDUM No.15783 DT.11.09.2017

The terms and conditions for sale of Phal kenduleaf for 2017 and arrear crops communicated vide memo No. 15639(250) dt.07.09.17 and Notice No.14768 dt.22.08.17 for e-tender sale during 11.09.17 to 14.09.17 are partially modified as follows:-

1.Clause No.11(b) of terms and conditions and clause No.3 of the notice No. 14768 dt.22.08.17:- Earnest Money Deposit:-

For advance sale of Phal kenduleaf lots, the intending purchaser is required to deposit Earnest Money @Rs.50/- per SB for the notified quantity in the lot or Rs.80,000/- per lot whichever is higher. The EMD will be paid through RTGS/NEFT sent in advance. No GST will be paid on EMD.

2. Clause No.9 and Sl.No.4 of notice No. 14768 dt.22.08.17

The tenderers shall have to pay Rs.500/- (Rupees Five hundred only) along with GST @5% either in the form of Bank Draft drawn in favour of OFDC Ltd and payable at any Nationalised Bank at Bhubaneswar or through NEFT, towards participation fees in the e-tender sale. The participation fee and GST as above being non refundable is to be deposited without linking to the EMD.
