TERMS AND CONDITIONS FOR SALE OF PROCESSED KENDU LEAVES OF 2018 CROP, IN MINI AUCTION SALE ON 18.06.2018

1. Bidding will be allowed only to the purchasers registered / renewed for the purpose with Odisha Forest Development Corporation Ltd. (OFDC) for the financial year 2018-19. A person representing a registered purchaser should be in possession of valid original registered power of attorney. An attested photo copy of the said power of attorney, shall be furnished to the Authority conducting the auction as well as the concerned Divisional Manager (C-KL) before taking part in the auction. The act of taking part in the auction will be deemed as unconditional acceptance of all the terms and conditions of the sale notice by the bidder.

EXPLANATION- For fresh registration, a purchaser is to apply online in our website (www.odishafdc.com) along with certificate of provisional registration in form GST REG-25, particulars of address, e-mail I.D., PAN card and mobile number etc. A customer interface (customer login) is available in the home page of the website for the purpose. During registration, attested copies of GST registration certificate should be furnished / uploaded by each applicant. An amount of **Rs 20,000.00 (Rupees twenty thousand)** only is to be deposited either online / through NEFT or in shape of account payee bank draft drawn either in favour of Divisional Manager-CKL, Sambalpur payable at Sambalpur or in favour of OFDC Ltd payable at Bhubaneswar towards registration fee. The registration fee is refundable "as such" at the request of the purchaser and from that date, the registration will stand cancelled. Registration fee will be forfeited to Odisha Forest Development Corporation Ltd. in case of violation of any of the terms and conditions of sale.

Registration will remain valid for one financial year and is to be renewed every year on production of GST clearance certificate and on payment of **Rs.1000.00 (Rupees one thousand)** only towards renewal fee, which is non-refundable. Failure to renew the registration will debar a purchaser from participation in the sale.

2. Bid will be per quintal of processed kenduleave in whole rupee (exclusive of all taxes, duties, levies, fees etc.) and on ex-godown basis.

3. The weightment of processed bags has been standardized and for all purposes, each processed bag will be treated as net 60 Kg.

4. The intending purchasers are advised to inspect the Kendu leaf bags in different godowns after contacting the concerned Divisional Manager(C-KL) and /or Sub-Divisional Manager-KL before participating in the sale. Participation in the sale shall be considered as complete proof of the fact that the purchaser is satisfied with the quality and quantity of the stock.

5.The Authority conducting the sale shall have the right to reject/cancel any/all bid /offer including the highest bid(s) or to postpone or to cancel or to withdraw or to change the sequence of sale of any/all lot(s) without assigning any reason thereof. He may not allow a purchaser(s) to participate in the sale for his discourteous behavior, causing obstructions in the sale process or acts in a manner detrimental to the sale/auction process. He may at his discretion reject the highest bid of any purchaser whose performance with regard to payment and lifting of materials purchased by him in any of the sales conducted during last two years has been irregular and unsatisfactory. He shall not be answerable in any court of law or in any forum in any manner for rejection of any sale.

6.Sale once finalized in favor of a purchaser can not be subsequently transferred wholly or partly to any other purchasers/firm.

7.The purchaser shall be bound by all Forest Department rules and regulations in vogue in connection with the purchase and transit of the Kenduleave.

8.The purchaser shall furnish his e-mail id/postal address clearly to which all the communications relating to sale will be sent. Any letter or communication sent to purchaser on such address either by e-mail or registered/ speed post will be deemed to have been received by him even if it returns undelivered.

9.The highest bidder in case of Processed leaves whose offer is accepted shall pay the full sale value together with GST, and duties etc. as applicable on the date of sale, on fall of hammer. However, the payments in respect of the lot(s) sold in the afternoon session shall be accepted till the next day during office hours. A purchaser who becomes the highest bidder for more than 2 (two) lots will be required to pay part sale value @25% of the sale value of 3(third) and subsequent lots on the same day and pay balance of the full sale value together with taxes and other charges etc. within 7 (seven) days from the date of completion of the auction sale.

a) If the due date of payment falls on a holiday, the next working day will be treated as the due date of payment.

b) No unadjusted advance amount lying with O.F.D.C. Ltd. will be adjusted towards sale value of the lot(s) of mini auction. Failure to pay the sale value as above will result in cancellation of sale as well as registration along with forfeiture of any sum already paid including registration fee and the lot(s) will be resold at the risk of the purchaser.

10. N.B.:- For the purpose of transfer of funds through RTGS/NEFT, the purchaser(s) has to transfer the funds from his/their account. No transfer from account of other individuals/firm will be entertained.

11.The highest bidder will lift the lot(s) within 22 (twenty two) days from the last day of auction sale. In the event of failure to lift the materials within 22 (twenty two) days, the sale will automatically be treated as cancelled with forfeiture of total deposits. However extension of time for lifting of the stock up to 1 (one) more week may be granted at the discretion of the Director(C)/Managing Director by imposing penalty @ Rs.1000/- per lot per week or part of a week. If the bags are not lifted within the extended period, the stock would be treated as “unclaimed property” and put to resale by the concerned Divisional Manager in the next sale at the cost and risk of the purchaser.

12.Taxes as per GST Act. and other fees and duties etc. as would be applicable on the date of sale/billing will be charged over and above the sale price and to be realized from the purchaser. Income Tax and surcharge as applicable will also be collected at source as per provisions of section 206[C] of Income Tax Act from the purchasers except those who produce the required exemption certificate from the Assessing Officer of the Income Tax Department to the extent of such exemption limit fixed and as mentioned in the said certificate.
