The Supplier warrants that the Goods supplied under this contract are new and free from damage and defects, of the most recent or current models and they incorporate all recent improvements in design and materials relevant to our specification. The Purchaser/consignee shall promptly notify the Supplier in writing/Fax/Telephone of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall immediately replace the defective goods or parts thereof without cost to the purchaser.

On expiry of the warranty period, the spare parts and accessories related to the equipments as and when required, shall be arranged/supplied by the approved supplier on payment.

If the Supplier having been notified fails to rectify the defect(s) within 3 days, the Purchaser may proceed to take such remedial action as may be necessary, like forfeiture of Performance Security or recovery from security deposit being the amount of loss which will be decided by OFDC Ltd. incurred by the purchaser.

MODE OF DELIVERY OF EQUIPMENTS
