Quotations are invited from the Govt. registered electrical contractor / firm of Bhubaneswar jurisdiction for complete overhauling of one 250 KVA electrical transformer installed inside campus of this office located at A/84, Kharvelnagar, Bhubaneswar. The interested firms/electrical contractors may submit their quotations in a sealed cover addressed to the Manager (Commercial), Odisha Forest Development Corporation Ltd., A/84, Kharvelnagar, Bhubaneswar by 3.00 P.M of 15.03.2019 which will be opened on the same day at 3.00 P.M in presence of the bidders or their authorized representatives. The following terms and conditions are to be followed by the bidders failing which their quotation shall not be taken into consideration.

1. The quotations should be accompanied with E.M.D of Rs 5,000/- (Rupees five thousand) only in shape of Bank draft drawn in favour of Odisha Forest Development Corporation Ltd from any Nationalized Bank payable at Bhubaneswar, which is subsequently to be retained as Security Deposit for successful completion of overhauling works of the electrical sub-station of OFDC Ltd. The EMD of un-successful bidders will be returned after finalization of bids.
2. Xerox proof copy of valid electrical license, GST registration certificate, PAN card and work experience for particular job are to be attached with the quotation failing which the quotation will not be taken into consideration.
3. The transformer is to be overhauled completely with replacement of transformer oil and spare parts if any. Hence, the interested parties are requested to inspect the transformer before submission of quotation.
4. The approved firm/contractor will be assigned to complete the work within 15 (fifteen) days failing which the S.D shall be forfeited and other firm/contractor may be entrusted to take up the job at his risk cost.
