**Terms and Conditions for sale of Indica Car bearing registration No.OR-02AN-4244 with reference to Notification No.9222 dt.11.05.2018.**

1. Interested purchaser can inspect the vehicle bearing No. OR-02AN-4244 kept in the premises of Corporate office at A/84-Kharvelanagar-751001 on any working day between 11 AM to 5 PM. The act of giving offer in the tender form shall be deemed as a proof that the tenderer has inspected the vehicle and satisfied with its condition. The vehicle will be sold on "as is where is basis " and hence no complain at later stage shall be entertained .
2. The tender form should be filled up clearly and it should be legible. The full name and complete address with contact number and mobile number of the tenderer should be clearly written in the tender paper. The quoted offer should be written both in figure and words. Correction /over writing if any ,should be attested by the tenderer.
3. The tender paper should accompany with original copy of money receipt in support of payment towards cost of tender paper and demand draft of Rs.2,000/- (Rupees Two thousand only) drawn on any nationalised/scheduled bank in favour of OFDC Ltd and payable at Bhubaneswar towards EMD, other wise the tender will be rejected. No cash deposit towards EMD will be entertained. In case of successful tenderer, the EMD will be adjusted towards sale price and in case of unsuccessful tenderer, the EMD will be refunded.
4. The successful tenderer shall have to deposit the differential sale value within seven days from the date of issue of acceptance order, failing which the EMD will be forfeited.
5. GST @18% will be charged extra over the sale value which is to be paid by the tenderer .
6. The tender will be received up to 3 PM of 29.05.18 at Corporate office either through post/courier/person/ drop in box and opened thereafter in presence of the tenderer or their authorised representative. Offers received beyond the schedule date and time will not be entertained.
7. The successful tenderer shall have to pay sale value and taxes etc and remove the vehicle from the office premises within seven days from the date of acceptance of offer. On failure, ground rent @1% of the tender amount per day will be realised . When the ground rent exceeds the accepted amount (sale price), the tenderer shall have no claim over the

vehicle and the sale price so deposited will be adjusted towards ground rent and the vehicle will become absolute property of OFDC Ltd to be disposed otherwise at the risk of the tenderer.

8. The tools, implements and spare parts shall not be delivered with the vehicle. On payment of sale price along with taxes, the purchaser has to furnish an undertaking that the vehicle shall not be used for any unlawful activities after delivery of the vehicle.

9. The authority reserves the right to accept/ reject the tender without assigning any reason thereof.
