TERMS AND CONDITIONS FOR ANNUAL MAINTENANCE OF AIR CONDITIONERS

(Reference: – Quotation Call Notice No. 6915 /OFDC-25013/12/2022-Comm dt. 13.04.2026)

Offers for Annual Maintenance Contract (AMC) in respect of 5 numbers of 14 & 10 HP each with 49 outlets of Mitsubishi cassette A.C. of different capacity (3 ton & 1.5 ton) & 23 units of Split & Window A.C. of different make and model along with stabilizers as installed at corporate office of OFDC Ltd. as per details at Annexure-I are invited from the interested and reputed firms/agencies/dealers as per notice above. The interested firms are to ascertain the quality and functionality of these Air Conditioners and go through the following terms and conditions before submitting their offers. Submission of offers will be considered as complete proof of the fact that, the concerned firm/dealer/agencies have inspected the A.C.s and satisfied with the terms and conditions.

- 1) The firm /dealer/agency must have been registered under GST and copy of GST registration certificate along with PAN are to be enclosed with the quotation offer.
- 2) The firm/dealer/agency should have minimum satisfactory experience of three years in such maintenance work of Air Conditioners of any office/institution/ organization etc. and copies of certificates/work orders in support of proof of work experience are to be enclosed. It is preferable that the Offerer should either be a dealer or authorized service holder for maintenance of ceiling cassette air conditioners (Mitsubishi).
- 3) The contract period of work will be for a period of one year from the date of execution of agreement and on satisfactory performance the period of agreement may be renewed for further period as would be decided on mutual consent.
- 4) The interested firm/dealer/agency may either collect the quotation Form containing general bid information along with terms and conditions form this office on any working day on payment of Rs.200+GST @18% or download from our website www.odishafdc.com and in that case, a separate draft of Rs.236/- drawn in favour of “O.F.D.C. Ltd.” on any nationalization bank payable at Bhubaneswar, is to be submitted along with the offer towards cost of form. The cost of form is non-refundable.
- 5) The Offerer is to submit a bank draft worth Rs 10,000/- (Rupees ten thousand) only drawn on any nationalized/scheduled bank in favour of Odisha Forest Development Corporation Ltd. and payable at Bhubaneswar towards E.M.D. The EMD of unsuccessful bidders shall be refunded after completion of process.
- 6) The successful Offerer has to pay Performance S.D.@10% of the AMC (Contract Value) within 7days of issue of work order. The EMD shall be converted to Performance Security Deposit and differential amount if any will be paid by the quotationer, which will be retained by OFDC. In case of non-performance or unsatisfactory service, the contract so entered will be cancelled and the Performance Security Deposit will be forfeited to OFDC Ltd. On satisfactory completion of contract period, the Performance Security Deposit shall be refunded.
- 7) For un-satisfactory performance or violation of terms of agreement, the AMC can be terminated by OFDC during the contract period giving a written notice of 15 days.

- 8) The annual maintenance contract includes replacement of all defective spare parts of the Air Conditioners & its stabilizers, refilling of gas in compressors etc. However, the maintenance will not cover the replacement of body of the Air Conditioners/ Compressor/PCB unit etc. which will be borne by OFDC Ltd.
- 9) The Air Conditioners may be shifted from one room to another which will be done by the AMC holder free of cost. However, during shifting, the cost of copper pipes, rubber pipes etc. will be borne by OFDC Ltd.
- 10) The approved AMC holder will attend to the minor repair works of the Air Conditioners on the same day soon after receipt of intimation from the corporate office either over phone or in writing. In case of major repair, the A.C. can be shifted to the work shop at his risk and need be reinstalled within three days.
- 11) The firm/dealer/agency should quote their offer towards annual maintenance cost of 72 Air Conditioners excluding GST in format at Annexure-II. The cost towards AMC will be paid quarterly on submission of bill.
- 12) The Corporation reserves the right to cancel the entire quotation without assigning any reason thereof.
- 13) In case of any dispute, the matter shall be referred to the Managing Director, OFDC Ltd. whose decision shall be final and binding on both the parties.
- 14) For legal dispute, the same shall be referred to the Court within the jurisdiction of Bhubaneswar only.
